ORDER

To facilitate the evaluation of the *Application* for the approval of the sale of various sub-transmission lines/assets of the National Transmission Corporation (TransCo) to Cebu I Electric Cooperative, Inc. (CEBECO I), an ocular inspection shall be conducted by the Inspection Team of the Commission on 18 January 2024 (Thursday) from nine o'clock in the morning (9:00 AM) to five o'clock in the afternoon (5:00 PM).

Relative thereto, CEBECO I is **DIRECTED TO POST** this *Order* in a conspicuous place within its premises and ensure that the same is done at the Offices of the Provincial Governor and Mayors of the Cities and Municipalities within CEBECO I's franchise area. CEBECO I must employ other practical means for the public dissemination of the scheduled ocular inspection.

CEBECO I is **DIRECTED TO SUBMIT** proofs of compliance with the posting and public dissemination requirements to official electronic mail (e-mail) address of the Commission's Central Records Division (CRD) at docket@erc.ph, following the requirements under Section 1, Rule V of ERC Resolution No. 09, Series of 2020.

Within five (5) days from the date that the Commission's CRD acknowledges receipt of CEBECO I's email for proof of compliance, CEBECO I is also **DIRECTED TO SUBMIT** one (1) set of the original or certified true hard copy of said proof of compliance, following the requirements under Section 2, Rule V of ERC Resolution No. 09, Series of 2020.
